Number Games

Some people have expressed curiosity regarding the number of Hartwells. My 2007 genealogy shows that while William¹ of Concord had only two sons, the number of Hartwells increased so much, that in generation six, there were 371 boys and girls surnamed Hartwell.

The following generations produced these numbers: Generation 7 - 950 boys and girls named Hartwell born (a huge increase in just one generation). Generation 8 - 1,460 (another large increase) Generation 9 - 1,551 (not much, but still an increase) Generation 10 - 1,320 (a slight decrease) Generation 11 - 1,231 (another slight decrease) Generation 12 - 681 (a major decrease) Generation 13 - 254 Generation 14 - 55 to date

Why have the numbers gone down after generation 9? There are probably a number of reasons. Generations 13 and 14 are probably not yet complete. Also, families are no longer as large as they once were. Where married women once had a baby about every two years during the course of their fertility, families now mostly limit themselves to one or two children. Also, recent marriages and births are not recorded publically, so unless someone reports these events to the Hartwells of America, they remain unknown to us. The most recent census available to the general public was taken in 1940, and most other on-line records, except for deaths, limit themselves to the years prior to 1900, or even earlier.

I'm sure there are lots more descendants all across the country, whose information I do not have access to, and who are not interested enough in their "roots" to contact me or the Hartwell Association. There are also lots of Hartwells who are not descendants of William¹ of Concord.

Since the 1940 federal census became available online, I have been trying to look up the many Hartwells whose names appear either on the Social Security Death Index (SSDI) or on websites such as www.legacy. com or www.findagrave.com. Any Hartwell born before 1940 that I cannot identify will eventually get searched. However, this process can be frustrating. Sometimes, nothing comes up that seems relevant. Other times, I find the person I'm searching for living with his or her widowed and/or divorced mother. Since the marriage (as well as the separation) probably took place between the ten (or 20 in the case of 1880 to 1900) year gap in census records, there is no way to determine who the father may have been. For every person I can "attach" there are probably three or four that I cannot track back to a known descendant of William of Concord.

While the SSDI does not identify ethnicity, census records do. There are many Hartwells, especially in South Carolina and other southern states, who are identified as "black" and/or "mulatto." One person I was tracking was identified in 1910 as "black" and in 1920 as "white." What to believe? Census records also indicate the birthplace of the head-of-household's father. Surprisingly, some Hartwells claim their fathers were born in such places as Norway, Russia, Japan, or, not quite so surprisingly, England, so they are probably not descended from William (unless they gave the census taker false information).

Following is a list of found Hartwell deaths in 2012, and thus far in 2013. Those in bold are definitely descendants of William¹ of Concord. The rest are unidentified.

We regret the omission of the death of **Albert Thomas**⁹ **Hartwell** from last year's newsletter list. "Alan," as he was better known, was born 13 Sept. 1936 and died 1 August 2011, age 74y and was a member of the Association for many years.

Minutes of the 2012 Annual Business Meeting of the Hartwells of America

On Saturday, June 30, 2012, twenty-two Hartwell cousins and friends assembled at the Trinitarian Congregational Church, Concord, MA, for the Hartwells of America Association's Seventy-Fifth Annual Reunion. Not a huge turnout, but on par with recent years. As is generally the case, the weather could not have been better.

President Wayne E. Hartwell (Foxborough, MA) called the business meeting to order at 12:35 p.m.

William C. Hartwell (Foxborough, MA) offered an opening prayer, after which a moment of silence was observed in memory of Hartwell cousins deceased since the last Reunion.

First-time Reunion attendees Nancy Hartwell Engel and husband Berny (St. Louis, MO), Karl E. Hartwell (Gorham, ME) and son Michael Karl Hartwell (Leominster, MA), and Donna Keane (Reading, MA) were recognized.

The minutes of the 2011 business meeting, as published in the 2012 Newsletter, were accepted.

David Hartwell Webber (Dunstable, MA) delivered the Treasurer's report. The balance on hand in the Scholarship Fund at the close of the Association's 2012 Fiscal Year totaled a very respectable \$17,293.81, including donations received during the Fiscal Year in the sum of \$90.00. The Operating Fund, which pays for the Reunion, Newsletter, and other Association operating expenses, stood at \$2,286.81. Operating Fund revenue for the year, from bank interest, dues, and the sale of Hartwell literature, totaled \$1,114.00. Expenses for the year for Scholarships (two at \$200), Newsletter, postage, the Reunion, and a \$25 donation to the Friends of Minuteman National Park were \$1,028.18. Net revenue from Genealogy sales was \$645.06.

Scholarship Committee Chairperson Marilyn Booth Manzella (Framingham, MA) reported that two grants from the Scholarship Fund had been awarded for the 2012-2013 academic year. Perennial Reunion attendee Tina Seeger (Pepperell, MA), an entering freshman at Williams College, Williamstown, MA, planning on majoring in Liberal Arts, was awarded \$20-0, as was Renee Lynn Cronin (Danville, CA), also an entering freshman, attending Boise State University. Boise City, ID, major as yet undeclared.

Genealogist Joy F. Peach (Lancaster, MA) reported that she did not have much to report as correspondence concerning Hartwell "stuff" during the year had been very light. Joy encouraged everyone to contact her with any pertinent information.

Contributions were voted to Trinitarian for the use of its facilities (\$250), to the Social Law Library for the efforts

of the Library's graphic designer in preparing the Association's Newsletter (\$50),

Regarding the annual awards, the Engels from St. Louis pulled off a near clean sweep. Nancy was the eldest lady in attendance, while Berny was the eldest gentleman. Nancy also picked up the prize for traveling the farthest to attend. The youngest attendee was Tina Seeger (a repeat winner). Hartwell Tavern tote bags were distributed to the winners.

The final vote of the day was to return to Trinitarian for the 2013 Reunion.

Following the business meeting, Karen H. Samuels (Bethlehem, PA) gave a very interesting talk and slide presentation on the use of DNA analysis in genealogical research (see story below), after which everyone assembled outside for the group photograph by Association Photographer Katy Hartwell (Foxborough, MA).

Your DNA as a Genealogical Tool

At the 2012 Hartwell Reunion, I had the pleasure of presenting my positive experience with researching my Hartwell lineage through my family's DNA test results. My sister, Deborah Hartwell, convinced me that some of you would find the subject interesting. Through Ancestry. com, I submitted three DNA tests of my brother Richard,

my son Teddy and myself. There are several reliable companies out there that do this service. I chose Ancestry.com because they offered a members' discount. In 2009, I asked my brother and son to submit a DNA test because at the time you could learn much more information from male DNA. The test looked at the male

Y-chromosome sample which represents the DNA of the father, paternal grandfather, and so on up the paternal line. Y-chromosome results are generally identical throughout the paternal line. We learned that my brother was in the haplogroup R1b. About 70% of individuals

currently residing in southern England are members of this group. The science has improved so rapidly since 2009 that the test now can tell you much more, whether you are male or female.

Ancestry.com matches your DNA results with other members' tests results. There was a perfect match



between my brother and a gentleman named Trevor Hartwell. Trevor lived in California and no one in my immediate family knew of him. I contacted Trevor through Ancestry and he graciously agreed to try to solve the mystery. We quickly determined that we were connected through Edward Hartwell

Trevor Hartwell

(1716-1799) who was born in Worcester, Massachusetts and moved to Alstead, New Hampshire. He married Elizabeth Kneeland (1719-1805) and their younger sons would move from New Hampshire to Maine, New York, Illinois, and Wisconsin. Trevor's ancestors moved further west with each new generation and ours remained in the northeast. Trevor wrote to me,

"It's a fascinating story regarding utilizing science and genealogy to make connections. I don't know if I told you or not but using DNA and connecting with you and your brother helped solve a mystery in my genealogy. In the Hartwells of America genealogy, there's a mystery regarding my 4th great grandfather (John) and whether he was first generation American (from Wales) or John "from NY" who is a descendant of William of Concord. Comparing our DNA has proven that I am indeed related to the William of Concord as your brother and I share the same 46 markers of our Y-DNA which probably wouldn't be the case if I wasn't a descendant of William of Concord."

My sister, brother and I are now facebook friends with our "cousin" Trevor. Advances in science and technology are making our world smaller and smaller. The Hartwell family has been fortunate to have dedicated genealogists like Joy F. Peach, John F. Hartwell, and Lyman W. Densmore who have done the hard work for us. We can use DNA testing to answer stubborn mysteries and fill in the gaps. I mentioned that I took a DNA test as well, at a cost of \$99. The test I took in 2012 looked at a massive amount of DNA, over 700,000 locations, and compared it to other DNA samples from around the world. DNA autosomal testing technology includes the entire genome-all 23 pairs of chromosomesas opposed to only looking at the Y-chromosome or Mitochondrial DNA. I had to laugh when the report stated that they were 99% sure that Teddy was my son. I am 100% sure! It also said that my genetic ethnicity revealed that all my ancestors lived hundreds—perhaps even thousands-of years ago in the British Isles. I have been contacted by 36 fourth cousins that were matched through our DNA tests. We determined the mutual ancestor in all these matches. I have researched several 5th cousins or greater matches and sometimes found the mutual ancestor in the United Kingdom. Warning to the wise...amateur genealogy is like a black hole. You can lose countless hours as you are mesmerized by the hunt!

I'll admit I am hooked on these DNA tests. I'll keep submitting my DNA as the tests become more revealing. Although the DNA tests I described only look at lineage, other tests are saving lives and freeing the innocent from prisons. Today you can buy a DNA paternity test over the counter at a CVS Pharmacy. Some may find these types of tests too invasive but there is no question that the more we know about our DNA the better we can prepare to live the healthiest life.
