




News 2014

While reading an article entitled "Samuel's Story, Recovering a Forgotten Nineteenth-Century Life," the name Emily Locklin, daughter of Joshua and Miranda (Hartwell) Locklin, popped out at me. I then remembered that the author, Peter Cooper, had contacted me, and in turn I had put his request for information about Emily Locklin and her husband, Samuel Cooper into the annual newsletter. Minutes of the 2013 Annual Meeting of the Hartwells of America

On Saturday, June 29, 2013, thirty-four Hartwell cousins and friends assembled under perfect skies at the Trinitarian Congregational Church, Concord, MA, for the Hartwells of America Association's Seventy-Sixth Anniversary Reunion.

Following a morning of coffee and pastries, getting up to speed on Hartwell facts (and gossip), and luncheon, President Wayne E. Hartwell (Foxborough, MA) called the business meeting to order at 1:00 p.m.

Roger Whitcher Hartwell (Quincy, MA) offered an opening prayer, followed by a moment of silence to remember Hartwell cousins departed since the last Reunion.

First-time Reunion attendees were introduced and welcomed. Robert M. and Teri Hartwell (Columbus, OH), although not themselves first-timers, having first attended the 1998 Reunion, brought along ten family members who were: son Joshua Hartwell (Columbus, OH); son Robert II, wife Brandie, and daughters Willow and Sadie (Columbus, OH); daughter Heather Hartwell-Ricardo, daughter Hallee Hartwell-Limes, son Kilen Hartwell-Limes, husband Shawn Ricardo, and daughter Stella (Westierville, OH).¹ The meeting notes are a bit fuzzy on the point, but it appears that Thomas W. and Georgia Ann Hartwell (Reynoldsburg, OH) were also first-time attendees.

The minutes of the 2012 business meeting, as published in the 2013 Newsletter, were accepted.

David Hartwell Webber (Dunstable, MA) delivered the Treasurer's report. The balance on hand in the Scholarship Fund at the close of the Association's 2013 Fiscal Year totaled \$17,054.22, including donations received during the Fiscal Year in the sum of \$45.00. The Operating Fund, which pays for the Reunion, Newsletter, and other Association operating expenses, stood at \$1,947.73. Operating Fund revenue for the year, from bank interest, dues, and the sale of Hartwell literature, totaled \$658.00. Expenses for the year for Scholarships (four at \$200), Newsletter, postage, the Reunion, and a \$50 donation to the Friends of Minuteman National Park (for 2011 -2012) were \$1,414.88. Net revenue from Genealogy sales (14) was \$743.92.

Scholarship Committee Chairperson Marilyn Booth Manzella (Framingham, MA) reported that a total of five applications were received for the 2013-2014 academic year. One arrived well after the deadline and was disqualified. For the remaining applicants, Joy Peach verified their

Hartwell connections and Dave Webber confirmed that either the applicant, their parent, or grandparent was a paid-up member of the Association. Editorial Musings

The Internet is a wonderful source of Hartwell family history misinformation, not to mention outright fabrications. Case in point: there are erroneous (and oft-repeated) references to the "1636" chimney which is little of what remains of the Samuel Hartwell house on Lincoln's Battle Road in Minuteman National Historical Park. Truth be told, William1 and his fellow settlers spent 1636 in earthen huts to the west in Concord. On Google Images, you can find photos of the Hartwell Tavern labeled as "Hartwell Tavern and Brothel"; of course, nothing in the historical record supports that slanderous assertion. To be fair, there are on the Internet credible sources as well.

Your Editor happened upon a very interesting September, 1968, report by one John Luzader for the National Park Service's Division of History, Office of Archeology and Historic Preservation, entitled "Samuel Hartwell House and Ephraim Hartwell Tavern Historic Structures Report" ("1968 Report"). Completed just seven months after the Samuel Hartwell House, then operated by Marion Fitch and Jane Poor since April 19, 1925 as "Hartwell Farm," a very popular restaurant (although they never called it such), was leveled by a fire, the subject of inquiry was whether the Samuel Hartwell House and the Hartwell Tavern were of sufficient historical significance to be restored and utilized in the development of the park. Fortunately for us, Mr. Luzader recommended that "the ruins of the Samuel Hartwell House be stabilized and interpreted through a professionally planned and produced wayside marker" (1968 Report at 29), and that the Hartwell Tavern "be restored and used as a historic house museum[.]" *Id.*, at 30. See *id.*, at ii, Administrative Data Section. By the way, the Samuel Hartwell was most likely constructed between 1693 and 1716, probably before 1709, long after 1636. *Id.*, at 28.

The 1968 Report poses some interesting questions about the time-worn story of Mary Flint Hartwell's and the slave girl Slukey's activities on the night of April 18, 1776. Among other things, Samuel Hartwell never owned a slave; his father owned Violet, but no other member of the Hartwell or Flint families were slave owners. *Id.*, at 22. Mr. Luzader attributes discrepancies in accounts of that evening to the fact that Mary's recollections of that evening were not published until nearly a half-century after her death (at 98) (*id.*, at 26) and to filiopietistic reasons. (id. at 27) (for you non-logophiles, the word means "of or pertaining to reverence of forebears or tradition, especially if carried to excess").


